SESSION 1

B1 - The Architect's Role Brian Waters will debate the role of the architect in the current climate and the need for the architect to manage construction projects. Following this, Amanda Baillieu will chair what will be a lively 15 minute debate on the role of the architect.

C1 - Designing and marketing your practice Eric Schneider, Schneider and Partners, is a qualified architect who now specialises in strategy, marketing and design under the umbrella of management consultancy. He encourages effective management of clients, helps organisations maximise their creative resources thus allowing people to realise their full potential. He will highlight how to design your practice to be consistent with your goals, highlight how to design and develop marketing strategies essential for today's digital age and encourage delegates to design and manage the consumer experience which allows you the best chance of differentiating yourself from the competition. He will also focus on how to get prospective clients and others to work with you; how to ensure client loyalty and how to maximise levels of enthusiastic word of mouth referrals.

SESSION 2

B2 - Town Planning Update and localism issues. Andy Rogers, ACAPAG chairman and architect-planner will discuss current issues in planning. He will highlight localism issues and the changes to the planning regime.

C2 - Partnering Contracts Dr David Mosey, author of the highly successful partnering contracts PPC2000 and TPC2005 will discuss good practice and the principles and advantages of partnering on construction projects. David heads up the construction division at Trowers & Hamlins and will highlight a number of case studies to introduce delegates to the contracts. Hackney Academy, one of the tour options, was built under this contract and is the perfect collaboration between spectacular design, good management and project efficiency.

SESSION 3

B4 - Building Regulations Update Geoff Wilkinson, The Building Inspector and AJ columnist will give an outline to the changes recently announced in Building Regulations. Geoff is a chartered surveyor and fire engineer who now advises clients on how to solve problems they may have with Building Regulation compliance and Fire Safety.

C3 - A new view of sustainable construction Tim Pollard, Head of Sustainability, Wolseley. As around 46% of the UK carbon emissions come from buildings, the construction industry is a key area in the drive for reductions towards the 2050 target. This is evidenced in the continued introduction of legislation and regulation designed to accelerate progress. Construction clients are re-writing specifications to encompass new goals as the emerging 'green economy' gathers momentum. Tim will look at some of the drivers likely to stimulate take up and will define the scale and pace of the challenge ahead. He will highlight some of the practical solutions commercially available to achieve more sustainable buildings from the experience of Wolseley as one of the leading suppliers of construction materials in the work.

SESSION 4

B3 - Avoiding Risk and getting paid Colin Jones of Hewitsons and Stephen Yakeley of Yakeley Associates are the authors of ACA SFA - the Standard Form of Appointment of an Architect and will discuss the benefits and pitfalls of a number architectural contracts. Colin specialises in construction and procurement law with considerable experience acting for consultants, contractors, developers and occupiers of construction projects. He is adviser to the ACA on its forms of appointment. Stephen is an architect and author. In addition to the ACA SFA series, Stephen has co-authored the concise form of interior designer's appointment CID/11 and co-authored The BIID Interior Design Job Book. Colin and Stephen will outline the areas of concern in appointment documents, how to avoid them and how to secure payment.

C4 - An introduction to Passivhaus ACA Council member Dieter Jandausch will discuss the basic principles of Passivhaus standards and construction and how to deliver your project to passivhaus standards.
